





"Inefficient " supply chain as a result of scale sizee.g. FCOJ - cane sugar is shipped per FCL instead of bulk ship



Limited availability



Limited origins



Immature market

Supply - demand issues
Price fluctuations



New supply takes on average 2-3 years for development (conversion from conventional farming to organic methods)



Challenges in Organic



- Organic integrity !
- EU regulating is getting more and more strict on residue levels
- Relative small market therefore big price fluctuations
